The Opportunity

OSI is looking for a Grants Manager to lead the City's effort to maximize the use of federal grants to meet priority community needs. The Grants Manager will lead a team of individuals working towards the efficient and transparent use of federal funds to improve low-income neighborhoods and provide quality affordable housing and services to Arlington residents. This team is responsible for administering Community Development Block Grants, the HOME Investment Partnerships Program, and Emergency Solutions Grants, among other grant sources. The team is also responsible for producing the Five-Year Consolidated Plan, Annual Action Plans, and the Consolidated Annual Performance and Evaluation Report (CAPER), in addition to other required federal documents and reporting.

The Grants Manager will ensure adequate oversight of federal programs, strategic use of grant funds, and reporting of positive results. The individual in this role will also seek other grant resources and develop new and creative ways to use resources to meet community needs. The team has recently expanded to include the Volunteer Income Tax Assistance Program, a key anti-poverty strategy to help working families access free tax preparation and related financial literacy services.

The Grants Manager is a key position in the City, responsible for developing an inclusive culture that uses data and community feedback to inform decisions, identify trends, and support its evolving performance management efforts. This individual will apply a solid foundation of related experience, an innovative perspective, and optimism while working with a strong team to enhance the organization's ability to address community priorities. The Grants Manager will work closely with the City's executive leadership team to help guide the organization's plans and programs.

Lead, motivate, and provide training opportunities for a team of professional staff to effectively administer federal grant programs and projects.


Develop effective strategies for working with community stakeholders to further goals that benefit low- and moderate-income Arlington residents.

Arlington's Grants Management team administers federal grants including Community Development Block Grants, HOME Investment Partnerships Program and the Emergency Solutions Grant.


